## RESOLUTION NO. 2021-35 VILLAGE OF ROSEVILLE, OHIO PERRY AND MUSKINGUM COUNTIES

## AN EMERGENCY RESOLUTION TO AMEND SECION 1 OF RESOLUTIONS 2021-12 AND 2021-14 TO INCLUDE THE WORDS "CURRENT EXPENSES" AMONG THE EXPENDITURES BEING COVERED BY THE TAX LEVY PLACED ON THE NOVEMBER 2021 BALLOT.

WHEREAS, the Village of Roseville, Ohio is a village formed and organized pursuant to the Constitution and laws of the State of Ohio; and

WHEREAS, the Village Council in regular session on April 20, 2021 passed Resolution 2021-12 establishing the need to renew a four (4) mill tax levy for a five (5) year period, and requesting that the Fiscal Clerk request the County Auditor certify to the Village the dollar amount estimated to be produced by said tax levy; and

WHEREAS, the Village Council in regular session on June 15, 2021 passed Resolution 2021-14 determining the Village's intent with proceeding to place said tax levy on the November 2021 General Election ballot; and

WHEREAS, said resolutions stated the funding from the tax levy would be used for: "the benefit of the Roseville General Fund...for purposes of providing and maintaining general operations, police department, buildings, or sites therefor, or the payment of permanent, parttime, employees or companies to operate same, including the payment of the employees medical and retirement benefits..." and

WHEREAS, the Village Fiscal Officer has recently been notified by the Perry County Board of Elections that the language of such resolutions must include the language "current expenses" as part of the language in each resolution in order to comply with statute;

## NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF ROSEVILLE, PERRY AND MUSKINGUM COUNTIES, OHIO, THAT:

Section 1. That the Council of the Village of Roseville is amending Section 1 of prior Resolutions 2021-12 and 2021-14 by including the words "current expenses" after the phrase "for the purpose of..." in Section 1 of each aforementioned Resolution.

Section 2. This Resolution is hereby declared to be an emergency measure, necessary for the preservation of the public peace, health, welfare and safety of the Village of Roseville. The reason for the emergency is to ensure prompt editing of the affected Resolutions prior to the tax levy being timely placed on the November 2, 2021 ballot.
