**A RESOLUTION AUTHORIZING MOVING THE VILLAGE ADMINISTRATOR POSITION FROM PART-TIME TO FULL-TIME, PROVIDING COMPENSATION ACCORDINGLY, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Village of Roseville is in critical need of a full-time Village Administrator to help manage various public works projects involving streets, water, and sewer and departmental employees; and,

**WHEREAS**, the Village of Roseville currently employs Jeffrey Slack on a part-time salaried basis to oversee the Village's public works administration; and,

**WHEREAS**, the Village Council desires to employ Jeffrey Slack on a full-time salaried basis.

**WHEREAS**, the Mayor recommends adoption of the Resolution as an emergency measure immediately necessary to pass for the health, safety, and welfare of the people of Roseville, to wit: to provide adequate staffing and support for the Village's public works systems including, but not limited to water, sewer, and streets.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Roseville, Muskingum & Perry Counties, Ohio:

**SECTION 1:** The Council of the Village of Roseville authorizes the moving of the Village Administrator position from part-time salaried to full-time salaried for Jeffrey Slack effective January 1, 2022 at a rate of **\$31,200.00** annually.

**SECTION 2:** The Village will offer the Village Administrator fringe benefits offered to all full-time employees.

**SECTION 3:** This Resolution will take effect January 1, 2022.
